What happens now?

1. Ensure you read through the draft tenancy agreement at **www.futurelets.co.uk/students** to understand your obligations. Each member of your group must complete an application form.

You must provide the following documents with your application form:

- 1. student status letter
- 2. photographic ID (passport) and biometric residence permit (BRP) card for international students
- 3. student ID card.

Then your payment plan is confirmed by your customer service representative and you pay a holding deposit of £65.00 and each applicant signs the application.

- 2. Your tenancy agreement is generated and sent to each applicant and guarantor by email within seven days. Please check all the details are correct before you sign. You will receive an electronic signature app to sign your agreement.
- 3. Your guarantor will need to complete the guarantor form and provide their:
 - 1. photographic ID passport or driving license
 - 2. proof of address
 - 3. proof of employment.
- 4. Pay your deposit within seven days of receiving your tenancy agreement. The deposit should be made in one transaction and in full.
